Sociology of Mental Health and Illness (920:631)

This course serves as a general introduction to the sociology of mental health and illness. The first part of the course, presented by Professor Horwitz, focuses on social constructionist approaches to the study of mental illness and their differences with other approaches to this topic. The second part, presented by Professor Rosenfield, focuses on current dominant and alternative approaches in the sociology of mental health, as well as the impact of social inequalities on mental health problems.

Most of the required reading will be posted on the course's sakai site. Discussion questions should also be posted to this site.

Course grades are based on three requirements: 1) leading one or two discussion sections over the course of the semester (10%); 2) class participation (20%); and 3) a research paper on a course-related topic of the student's choosing that the instructor has approved (70%). Students will discuss their ideas for this paper in class on March 1 and present an oral summary of the paper on April 26.
